Chairman Taylor recommended Resolution 2022-09 and explained how this would communicate to the County Commission the particulars of a compromise. A quick resolution by March 21, 2022 would provide time for implementation of new voting machines for the August and November 2022 elections. Upon approval, Resolution 2022-09 would be forwarded to Shelby County Commission.

WHEREAS, TCA § 2-2-5-204 (b)(2)(B) describes the process by which a candidate may appeal the determination of a political party and that appeal is still undergoing; and

NOW, THEREFORE, BE IT RESOLVED BY THE SHELBY COUNTY ELECTION COMMISSION, that the list of candidates attached as Appendix A is certified for inclusion on the May 3, 2022 ballot; and

# RESOLUTION OF UNDERSTANDING REGARDING ELECTION EQUIPMENT

WHEREAS, the Shelby County Commission has informally expressed an interest in ending the impasse regarding the purchase of new voting equipment and indicated the possibility of funding the election equipment and accessories selected by the Election Commission with certain conditions; and

WHEREAS, the Election Commission is willing to continue with the litigation now in the courts but is willing to reach a compromise if the following conditions are part of this compromise:

- 1) The County Commission will act no later than March 21, 2022.
- 2) The voter may choose a hand marked or a machine marked ballot; neither option is a default.
- Quantities of ballot on demand printers and other accessories may need to be increased to accommodate the needs of early voting.
- 4) The County Commission will increase the Election Commission budget in an amount sufficient to cover the attorney's fees.

NOW, THEREFORE, BE IT RESOLVED BY THE SHELBY COUNTY ELECTION COMMISSION, that the Administrator of Elections is authorized to take all necessary actions to execute the purchase of new election equipment including adjusting quantities of items to be purchased.

# Administrator of Elections Monthly Report February, 2022

#### **Voter and Candidate Services**

- **Signatures** We are just about finished with this project and have updated nearly 40,000 records with electronic signatures. The microfiche book and page has been added to the voter registration records, so in the worst case, we can find the original application.
- **Petitions** 156 petitions have been pulled for the August election.

#### **Operations Department**

• **Polling Locations** – We finished up the polling place locations. It felt substantially more difficult to find polling locations this time – many, many locations turned us down.

#### Administrator

- Candidate Class We had a virtual candidate class on February 10<sup>th</sup>. 21 potential candidates and 14 staff members participated in this class. We will be scheduling an in person class in March.
- Deputy Registrar Training Three classes in February trained 44 volunteers.
   We have three meetings scheduled in March and these are almost full, so we will schedule some additional ones soon.
- Campaign Finance Training We will be holding a virtual training class for campaign treasurers and will delve into the details of filing campaign finance forms.

- **Speaking** I spoke to the Exchange Club last week. It was a nice group and they asked good questions.
- **High School Registration** Sherry went to the Memphis Business Academy and Central High School in February. So far, we have registered 677 high school seniors.
- Redistricting Obviously this has taken most of my recent focus but it is nearly complete. The all details list include now includes a voter's precinct and split as of December 1, 2021. Deborah Upchurch is at the Shelby County Commission meeting now, seeking funding for the mailing to the entire county. This has proven to be a very challenging process as the card stock of the appropriate weight has major supply chain issues.
- Maps The interactive maps referenced on our website are now updated. (www.ElectionsShelbyTN.gov/voter/Maps)
- New Maps and Lists The new maps and lists are now available. There will be an update to the all-details list tomorrow; it will likely be ready on Wednesday. It will again list a voter's precinct as of December 2, 2021. This will be the list that we use to do the county wide mailing.
- Election Center Special Conference Carla and I attended this meeting in Atlanta last week. It was an excellent meeting.
- Roof Leaks The roof is again leaking at the Operations Center. Building Services believes that they know why the roof has continued to leak and have a way to correct this.
