Voter and Candidate Services

• **List Maintenance** - We are continuing to do the list maintenance required under TCA§ 2-2-106. I do not expect this project to be finished until early August. I'll give final numbers when we are finished.

- **ElectionsShelbyTN.gov** ShelbyVote.com has not yet migrated to ElectionsShelbyTN.gov; our liaison with IT is on vacation, so I'm uncertain when this is going to occur.
- Audio and Livestream is archived at xfer.shelbycountytn.gov The login, which appears on the splash page, is public and the password is public. The livestream can be found on our Facebook page – Shelby County, TN Election Commission.
- Redistricting The Comptroller's office still anticipates that they will receive the census population detail on August 16th. It will take them about a month to

process the data into a form that can be used by the County Commissions, so we expect the data to be available no later than September 20, 2021. Redistricting must be completed by December 31, 2021. Our VR vendor needs about four weeks to get the new shape files loaded and tested in the UAT environment and then move to production and we need a few weeks to update all our materials. There are holidays in that time frame, so the County Commission needs to have made their decisions as close to the first of November as possible.

- May 2022 Primary Both parties have been notified of the August 23, 2021 deadline to call a primary election. As of this morning, neither party has notified us that they want to have a primary. Please remind your respective parties that there is no flexibility in that deadline.
- Section 203 Determination The Census Bureau plans to release the new Section 203 determinations in December. Section 203 of the Voting Rights Act requires a jurisdiction to provide ballots and all other public election materials in covered minority languages if certain thresholds are met. To be required to do so, the number of limited English proficient United States citizens of voting age in a single language group is:
 - o Is more than 10,000, or
 - o Is more than five percent of all voting age citizens, or
 - On an Indian reservation, exceeds five percent of all reservation residents;
 and
 - o The illiteracy rate of the group is higher than the national illiteracy rate

In the last determination in December, 2016, Shelby County had no minority language groups enough to trigger the requirement. However, we do have bilingual workers at the Operations Center on Election Day. Each polling place has a sign in Spanish advising voters that if they need assistance, they and the officer can call the center and translation will be provided. We also offer VR forms in Spanish and our website is built on a Google platform that automatically translates the base information into multiple languages. (This does not work with documents that are on the site in .pdf. We have worked with Latino Memphis and they have translated documents for us and posted them on their website. All county employees and visitors have access to the Language Line service.
