Ms. Gentry has been building the poll workers list for the August election and we have enough part-time staff for the election.

The Chairman encouraged everyone to vote in the upcoming election.

Attorney Swatley reported that the commission has one active litigation matter, a lawsuit filed by Marion Latroy Alexander-Williams, Jr.

ADMINISTRATOR'S REPORT:

AOE Phillips presented her report. Report is attached.

Commission discussion on certification date of the August 4, 2022 election pending delivery of new equipment and mandated deadlines. Date to certify will be scheduled by deadline.

Commissioners Kimbrow and Smith inquired about availability of paper ballots at poll locations for the August election as back-up. AOE Phillips confirmed that paper ballots are available and extra machines are also planned for poll locations due to the length of the ballot.

Commissioner Kimbrow asked what the policy is for public records requests. AOE Phillips informed that the policy is available on the website and plans are to utilize the Shelby County Mayor's Action System in the near future to automate the policy.

Commissioner Kimbrow asked where to find the current list of the approved poll workers assigned to each site and of those not being reassigned due to ineffectiveness, and how is that list made available to the Democratic Chair and the Election Commissioners. AOE Phillips responded that the list would come from the poll worker department.

OLD BUSINESS:

Chairman Luttrell expressed appreciation to Chairman Brooks, Mayor Harris, and those that worked to expedite the process to order the new machines.

Commissioner Smith asked for correspondence on server failures and for information regarding vendor support of old equipment. Discussion ensued on the history of the current equipment.

Commissioner Smith requested access to election commission building. A key will be provided.

Commissioner Smith will send a request for information through email as in previous elections to be filled by administration.

Administrator of Elections Monthly Report June, 2022

Voter and Candidate Services

- **New Campaign Finance Reports** All campaigns and candidates with open campaign accounts will need to file their 2nd quarter for the period that ends on June 30th. These must be filed by July 11th or July 15th depending upon the type of report. The start date of the report depends upon whether or not their election is in 2022 and if there was a primary.
- Absentee Ballots We had received 498 requests as of close of business Friday. 198 are UOCAVA; the rest are regular. More puzzling is the fact that we have only received 8 permanent absentee requests to this point; the letters were mailed out three weeks ago. If this doesn't pick up soon, we will do the mailing a second time.
- Overdue CFD The following candidates have been sent certified letters informing them of their overdue CFD for the pre-primary that was due 4/26/2022.

Operations Department

- Is in full election mode, so their entire focus is on preparing the machines and prepping for the election.
- Poll worker classes are occurring now.

Administrator

- New Election Equipment Thank you for your attendance today and the opportunity for us to reset following what's been a trying period as we advocated for new voting machines.
 - I realize that some of you felt uninformed or underinformed about the challenges we faced with our current machines during the May election. Please accept my apology for the unintentional communication gaps. Our team will aggressively work to keep you more informed in the future.
 - We are grateful that the Shelby County Commission did vote to replace the machines for the November election, but the fact remains that we are down to one working server for the August election. We are working with the vendor on strategies to cope if the server goes down at any point during the election season. But I need everyone to know that if the server goes down on Election Day, our election results could be delayed for up to two weeks while we compile the results manually. Since new machines are approved for November, this is the last time we will face this challenge.
 - Following the August election, we'll immediately begin training and communication about the new machines. Therefore, we are planning to distribute three RFQs to support this process: (1) voter outreach, (2) poll worker training videos and (3) poll worker training materials as LOSB opportunities. We will, however, softly begin the mammoth communication effort on Saturday, July 16, with a Voter Ready Expo at all Early Voting sites. At these events, voters will be able to vote early, register for the November election, find out their precinct locations and try out the new voting machines. The event is co-sponsored by our partner, the Shelby County Voter Alliance.

- We'll keep you updated on the progress of our machines throughout the August election season and let you know of any technical issues that may arise. We recognize the importance of this and every election and want to ensure you have the most up-to-date information necessary to make sound decisions on behalf of this body.
- The contract with ES&S has been signed and the purchase order issued. We expect to begin receiving equipment as early as next week.
- The RFQ for destruction of the existing equipment will be sent out shortly; this will be a LOSB opportunity.
- We will begin working with a local architect/engineering firm to plan the needed alterations to this building to provide fire resistant storage for the paper ballots and the construction of the two additional rooms to accommodate the new process required by the new machines. Building Services was planning this but concluded that they needed additional expertise to get what we needed.
- The resolution for the purchase of new electronic poll books should be on the County Commission agenda for the first meeting in July. Chairman Brooks is the sponsor of that resolution. We will be purchasing 600 additional poll pads from KNOWiNK to supplement the 100 we already own. As soon as the August election is over, the existing electronic poll books will be destroyed/recycled.
- **Budget** The County Commission did fund our request for a cargo van and added to our budget for janitorial services here at Nixon. They funded both elections.
- Recount The TN Democratic Party requested and paid for a recount of County
 Commission Districts 7 and 11. The recount was held on Wednesday, June 15. There
 were no differences at all between the certified results and the recounted results. The
 recount did delay us; it was a struggle to get the ballot finished on time.
- UOCAVA All military and overseas ballots went out by the deadline on Monday, June 20th. Kudos to Carla Lytle who worked all weekend to make that happen and to Genine Taylor and her team for staying late on Monday to make sure all went out.
- Petitions As of close of business on Friday, forty petitions had been issued for municipal races.
- Write-In's No local write in candidates filed the required statement by the deadline, so any write-in's recorded will not count.
- **Sound System** You may have noticed that the new sound system was finally installed. We started this process last July.

• Free Bus Day - We are working with MATA to have another free bus day on July 29th but those plans are not yet confirmed.

Outreach

- Held two deputy registrar classes in June the total trained in 2022 is 140. No classes are scheduled for July; they will resume in August. Right now, we have 232 active deputy registrars.
- The school year has ended, so we are making plans for the 2022-2023 school year. The TN SOS will again sponsor the Anne Dudley Award for TN High Schools. Year to date we have 1,221 paper apps from high schools.
- Supported 14 voter registration events with our Deputy Registers.
- Attended the following events:
 - Pride Fest Partnered with the SCVA for a registration/information booth.
 - Bartlett Library Summer Kick-Off we had a table at the event providing voter registration/election information.
 - Juneteenth Community Baby Shower voter registration
 - Girls Inc. Summer Program (continues through July 19th) partnering with the SCVA to provide voter registration and The Importance of Voting modules, including a mock election.
 - Spoke at the University of Memphis Civics Based Educators Conference.
 - Naturalization Ceremony For the first time in two years, we were able to have in-person voter registration with new citizens. 35 new citizens registered on paper and more used the QR code to register on line.
