SUPPORT SERVICES PRESENTATION ON 980 NIXON ROOF REPAIR PLAN:

Presentation by Nycole Alston, Administrator of Support Services and Jim Daniels, JD Ventures. Alston introduced Daniels as the vendor that will be addressing the repairs at 980 Nixon.

Daniels will begin testing and site work can begin by Friday of this week. Alston confirmed that purchase order was in place and work can begin immediately.

Questions on timeline by Commissioner Stamson. Daniels stated work should take about ten (10) days to complete, weather permitting.

RESOLUTION 2022-10: RESOLUTION TO APPROVE POLLING LOCATION CHANGE FOR THE MAY 3, 2022 COUNTY PRIMARY ELECTION:

Presentation by Carla Lytle, Operations Manager. Due to renovations at Gaisman Park Community Center a replacement location was found. The replacement location is St. Stephens United Methodist. Closest location available, will now be a dual site.

Commissioner Lee asked for clarification of dual location. Lytle provided information that more than one precinct will use the same voting location at different ends of the building. Commissioner Stamson asked for information on which precincts will be using St. Stephens United Methodist. Lytle will provide information at a later date.

OUTCOME OF MOTION: Passed Unanimously.

Commissioners congratulated Chairman Luttrell. The Chairman stated that he appreciated the confidence that his fellow commissioners have bestowed on him and that he appreciates and will rely on the Commissioners experience and expertise. The Chairman also stated his appreciation of the staff and their responsiveness and it is his objective to continue the traditions that have been established by this commission to continue to present to the public, the election process and its integrity. Chairman Luttrell also stated that he looks forward to continuing to work with the commission, staff, and political parties in concert to bring forth election confidence and if problems do occur then they will work with due diligence to resolve any problem before it becomes an issue. The Chairman thanked everyone for the opportunity to serve.

Commissioner Stamson commented on Chairman Luttrell's record of service with welcoming comments.

PROPOSED FY 2023 BUDGET:

Presented by Deborah Upchurch, SCEC Business Administrator. Upchurch summarized budget items of interest such as labor, equipment, and new line items. Commissioner questions and comments on line items and the process. FY 2023 Budget attached.

MOTION STATED: Commissioner Uhlhorn made a motion to approve.

SECONDED BY: Commissioner Stamson

OUTCOME OF MOTION: Passed Unanimously.

CHAIRMAN'S REMARKS:

ATTORNEY'S REPORT:

Attorney Swatley stated we are in litigation with Shelby County Commission re: purchase of new voting equipment.

ADMINISTRATOR'S REPORT:

Due to illness, AOE Phillips will distribute her report.

OLD BUSINESS:

Commissioner Lee asked for update on Resolution 2022-5, regarding early voting schedule from the March 28, 2022 SCEC Regular Meeting. Staff will respond with update.

Commissioner Smith asked about the poll worker hiring list from primary board selection in response to a text he received. Primary Board reported that the first two names had not been called on to work at this time. Chairman Luttrell responded that he researched this issue and found that early voting poll workers were hired from the existing list and election day workers were still in the hiring process and will use the established list.

In response to Weinberg public comment, Commissioner Uhlhorn inquired if Weinberg or any in attendance at the meeting would like to view the proposed voting equipment. There was some interest since not everyone was available in 2018 for the initial public viewing. Chairman Luttrell commented that there will be opportunities for the public to view any new equipment in the future.

RESOLUTION TO APPROVE POLLING LOCATION CHANGE FOR THE MAY 3, 2022 COUNTY PRIMARY ELECTION

WHEREAS, The Election Commission has been informed that the polling location for 13-02, Gaisman Park Community Center, located at 4223 Macon Rd., Memphis, TN 38112, is not useable for the May 3, 2022 County Primary Election by the Shelby County Election Commission and,

WHEREAS, the replacement polling location, **St. Stephens United Methodist**, **located at 3981 Macon Rd., Memphis, TN 38122**, has consented to the use of their facilities as an election day polling location for **13-02** and meets the Election Commission site standards,

NOW THEREFORE BE IT RESOLVED BY THE SHELBY COUNTY ELECTION COMMISSION, that the Gaisman Park Community Center, located at 4223 Macon Rd., Memphis, TN 38112, is not usable for the May 3, 2022 County Primary Election, and will be replaced with St. Stephens United Methodist, located at 3981 Macon Rd., Memphis, TN 38122, as a replacement polling Location, is hereby approved.
