SCEC received subpoena, SCEC is a nonparty, related to middle Tennessee lawsuit regarding felon voting rights restoration. We provided requested documentation and deposition by AOE Phillips.

Two active litigation matters; lawsuit filed by Marion Latroy Alexander-Williams, Jr. and an election challenge filed by Charlotte Bergmann, SCEC filing motion to dismiss on both matters.

Administrator of Elections Monthly Report May 2023

- Overdue Campaign Finance Reports There are still 21 overdue reports from August 2022 candidates a number of which are current office holders. There are 2 overdue reports from November 2022 local candidates and 32 overdue reports from candidates from earlier years with open accounts. All of these have been turned over to the Bureau of Ethics and Campaign Finance for enforcement. People who are on this list cannot run for office unless the reports and any fines assessed by BECF are paid by the qualifying deadline.
- How to Run for Office Class The first class was held Saturday and was attended by 15 people. This will be held again on June 13, 2023, at 5:30pm.
- **Do's and Don'ts of Campaign Finance Class** The first class will be in person on June 17th at the Operations Center. There will be a class via Zoom on June 20th at 5:30PM.
- **District 86 Special Primary –** All of the UOCAVA ballots went out ahead of schedule. We are ready for Early Voting which starts on Friday.
- **Memphis Municipal Election** Today was the first day to issue petitions. So far, the pace has been moderate with 9 petitions issued by noon today.

• Outreach

 We did 32 school events with a total of 924 voters registered. We are increasingly hearing from students that they registered on-line or when they went to the DMV. We demonstrated voting machines to 167 students; that was very well received by the schools and we hope we can do more next year. 54 schools failed to respond to a letter, an email, and three phone calls. Some of this is understandable – we don't generally ever visit the small religious schools and some schools are aimed at special needs students. We distribute applications to the parents of children at special needs schools, but we don't do a group registration.

- Deputy Registrar Classes We trained 5 new Deputy Registrars at the April class. The next class is May 23, 2023, and 12 people are registered.

 - Mayoral Conversation at the Shell
 - Several events at local churches
- Looking forward, we will be at the Pride Fest on June 3th and the Naturalization Ceremony on June 8th.

When compared to other election departments, Shelby County relies too much on temporary labor. This hurts us in many ways as temporary workers simply don't know as much as full time employees.

Education Manager - Lack of consistency in training is a particular area of weakness. This costs the county in many ways – voter frustration when poll workers don't get it right, increased costs for help desk, increased costs for technical staff.

Our most pressing need is for an Education Manager. This would be a person with teaching experience – preferably at the high school level. This person would develop curriculum, seminars, and training materials. They would conduct training classes for volunteers and trainers so that everyone representing the Election Commission gives the same message. While the benefits would not be immediate, by 2026, we should be able to reduce the expenses of the elections enough pay for this position. This would be accomplished by having better trained poll workers who will in turn require less help desk support and less technical support.

\$55,000 in Salary and \$22,973 in Fringe for a total of \$77,973.

Outreach Specialist - Another critical need is for more support in Outreach. Right now we can only devote about .35 FTE to Outreach efforts. While voter interest in the races on the ballot is the most critical factor in voter turnout, there appears to be a correlation between more spending on outreach and higher voter turnout.

\$45,000 in Salary and \$20,258 in Fringe for a total of \$65,258.
