AOE Phillips presented information on item. Trial run during May 3, 2022 Election was successful and recommended to eliminate zone transmission of unofficial election results permanently. New turn-in procedure was secure, timely, and went smoothly.

CHAIRMAN'S REMARKS:

The Chairman shared that he and AOE Phillips spoke briefly this week with media on behind the headlines program with Eric Barnes and Bill Dries about the May 3, 2022 Primary, plans for the future, election volunteers, and election equipment. Article from discussion was published in the Daily Memphian.

Over the weekend, the Chairman sent emails to the County Commission members, copying the Election Commissioners and AOE Phillips, outlining the voting machine issues that occurred during the May 3, 2022 Election with a strong appeal for new equipment.

ATTORNEY'S REPORT:

Attorney Swatley reported on five (5) active cases in litigation. The voting machine case is ongoing. Last Wednesday, AOE Phillips was served with a lawsuit by Marion Latroy Alexandria-Williams Jr. involving his eligibility to run in the May 3, 2022 election. His eligibility was denied by TN Bureau of Ethics and Campaign Finance issue. There are three candidate qualification challenges that the Election Commission had decided to bring before the Chancery Court for

determination. The Lee Mills matter was resolved and he is eligible to run for office. The Kenya Brooks matter was also heard and she is also eligible to run for office, still waiting on final order. The Amber Mills matter is in active litigation at this time.

cast on Election Day so that a slight increase in the time required to get the results to the

COMMISSION, that the memory devices from the election day machines will be returned

to the Operations Center.
