

Administrator of Elections Monthly Report January, 2020

Voter and Candidate Services

- 215 UOCAVA ballots for the deadline. Overall, absentee requests are not as high as we expected.
- Campaign finance notices for the fourth quarter were sent on time. Open committees at the end of the year (i.e. any campaign that doesn't have a zero balance) notices are going out to day.
- We have no backlog of voter registration applications; every form that can be processed is processed.

Operations Department

- We are in full on election mode so aside from our normal election activities there isn't anything to report.
- The public test of election equipment for the March 3rd election is from 9:00am to 11:00am on Friday, February 7th.

Administrator

- Voters DO NOT need a real ID to vote – only to get on airplanes and into federal facilities.
- The first day to issue petitions for the US Senate, US House, Tennessee Senate and Tennessee house primary and Shelby County School Board general election in August is Monday, February 3, 2020. Candidates who will be running the November municipal elections can pick up their petitions starting on Monday, June 22nd.
