- **Building Update** The soil cement has been placed for the parking lot. Once it has sat for 7 days, they will put a base coat of asphalt on and we will be able to use the back half of the parking lot. We are continuing to have roof leak issues in the flat part of the roof. This will not be fixed until next spring.
- Audit You need to set the date for the audit. The deadline to certify the election is Monday, November 25th, so the audit must be completed before then. We are going to have more teams to do this but there will be more ballots to count, so I don't think we can get it down to less than 2 hours.
- UOCAVA All UOCAVA ballots went out on time. We sent 1,234 by email and mail.
- Voter Registration We have processed 19,088 voter registrations since September 1st. Of these, 5,666 are new voters. 68.9% of the new voters are age 36 and under. Their age breakdown is:
