NEW PHOTO ID LAW

Federal or Tennessee government issued photo ID is now required to vote in person, unless an exception applies. College student IDs will not be accepted. City or County employees lds (Including library cards) are explicitly excluded and will not be accepted. To learn more about the new law and its exceptions, please call (901) 222-1200 or visit GoVoteTN.com.

Any of the following IDs may be used, even if expired:

- Tennessee driver's license with your photo
- United States Passport
- Photo ID issued by the Tennessee Department of Safety and Homeland Security
- Photo ID issued by the federal or Tennessee State government
- United States Military photo ID, including a Veteran Identification Card
- Tennessee-issued handgun carry permit with your photo
