

SHELBY COUNTY ELECTION COMMISSION
REGULAR MEETING
April 16, 2014

The Regular Meeting of the Shelby County Election Commission was held on April 16, 2014 at 5:00 PM at the Election Operations Center, 980 Nixon Drive. Commissioners in attendance: Chairman Robert Meyers, Commissioners Lester, Nollner, and Stamson in attendance. Commissioner Tate was absent.

Chairman Meyers recognized Barbara Williams from the League of Women Voters. Ms. Williams wanted to thank Mr. Holden, Mr. Holmes and Dee Nollner for arranging a very successful tour of the operations of the election commission. Great feedback great learning experience came away amazed with the amount of work involved in putting on an election.

DISCUSSION/APPROVAL OF MINUTES FROM JANUARY 22, 2014, REGULAR COMMISSION MEETING, AND MARCH 19, REGULAR COMMISSION SPECIAL MEETING

January 22, 2014 minutes were tabled. Commissioner Stamson moved to approve March 19, 2014 minutes. Commissioner Lester second. Minutes were unanimously approved.

ATTORNEY'S REPORT

Attorney Ryder presented the following report:

1. District 4, Shelby County School Board Election – Election on appeal. Kenneth Whalum verses Kevin Woods. New nine member school district approved by Judge Mays removed Mr. Whalum from District 4. Mr. Woods moving to dismiss appeal. Oral argument set for April 23, 2014.
2. Tomasik vs. Goins—Plaintiffs were awarded \$26,000 in attorney fees. Shelby County Election Commission is to divide 50/50 with State of Tennessee. Waiting on check to be issued.
3. Edith A. Moore vs. SCEC- Chancellor Goldin ruled in favor of Ms. Moore on the basis of registration *not* residency under Home Rule Charter. Ordered Ms. Moore's name be placed on the ballot.

CERTIFICATION OF CANDIDATES' NAMES TO APPEAR ON THE AUGUST 7, 2014 BALLOTS

Chairman Meyers stated that the Commission was given a 7 page handout of candidates' names to appear on the ballot as well as a slate posted on the wall. Commissioner Lester asked about Mr. Rout's qualifying petition. Mr. Holden stated that there were three (3) candidates that properly filed in Shelby County and qualified for State Executive Committee in District 32 however they failed to file their qualifying petition with Tipton County and therefore they will be on neither County's ballot. Rick Rout, Rochelle Stevens and Paula Sedgwick, were the petitioners. Mr. Holden stated the information was in their package. Commissioner Lester stated that based on those corrections she moved to certify the list as provided by staff. Commissioner Stamson seconded. Motion approved unanimously.

ADMINISTRATOR'S REPORT

Mr. Richard Holden presented the following report:

- He is scheduled to appear before the County Commission for the budget hearing. Will be requesting an increase in the amount of \$206,445 that was not included in the budget.
- Reported that policy for Board meeting agenda items is clear. Agenda items are to be submitted to Committee Chairman for inclusion on the committee agendas. The Chair develops the agenda for regular and special meetings. It is necessary for the agenda to be submitted to the AOE at least 3 business days prior to meetings. Staff will post agendas for public notice when approved by the appropriate Chairman. This allows for proper functioning of the meetings and proper public notice of agenda items.

Seventy three thousand eight hundred voters were cancelled and 57,679 moved to Inactive status. Combined total of active and inactive voters, 533,804.

The Easy Guide handout was well received and approved by the attorneys to be legal.

Commissioner Lester asked if there was a process in place for groups wanting to tour the Operations Center. Discussion followed. It was decided that any group wanting to tour should contact the Administrator. Participants should be limited to no more than 20 people.
