- **Building Update** – Much of the low voltage wiring is finished. Still waiting on the installation of some cameras and gate controllers. We are still awaiting some furniture.
- **Anne Dallas Dudley Gold Award** - The Gold award is given to schools that have 100 percent of the eligible students registered to vote. The 2026 winners are:

- **Anne Dallas Dudley Silver Award** - The Silver award is given to schools where 85% of the eligible students are registered. The 2026 Silver Award winners are:

 - **Power Center Academy**
- **Holiday** - We are closed for Good Friday on Friday, April 3rd since this is a state holiday. Monday, April 6, 2026, is a Shelby County Holiday which is not recognized as a state holiday. Since it is the last day to register to vote, both offices of the Election Commission will be open normal hours. We will observe the holiday on another day.
- **Outreach** – Has been extremely busy with both school registration events and community events. Notable events include Adulting 101, which has about 2,000 high school seniors come through. We registered 255 students at Cordova HS last week. Tomorrow we are doing an event with the Memphis Grizzlies where we will register some new Grizz players and about 400 MSCS students.
